#### Item 5 – ANNUAL REPORT 2018/19

In the last year Tollcross Community Council has been busy with many things that concern our area and the wider city.

We have welcomed two new councillors – Saty Kaur who became the CC Secretary and Andreas Wilhelm.

We have seen plans coming forward for a revamp of the Kings Theatre, including possible inclusion of a café on top. Beside this space we have finally had another consultation on the Canal to Meadows cycleway and are happy to report the plans are broadly good with work hoping to start within a year or so.

We have been working to sort out the dumping ground on Thornybauk with Cllr. Claire Miller. Together with Tollcross Primary School we have been engaged in discussions with the Council over a safer route to school, we are happy to say that money has been allocated and the two things are looking like they will receive the attention they have lacked over the years, very soon.

Where development in Fountainbridge is concerned we took a deputation to full Council led by Richard Allen regarding Edinburgh International Conference Centre wanting to put a massive hotel on land that has been the subject of community engagement and planning for over five years. We're pleased to say that the Hotel plans didn't stand up to a crass attempt by EICC to bypass the Committee and place its arguments in the Edinburgh Evening News as a done deal written by one of the Councillors who sits on the Committee. We are however very pleased to see early plans for that site being developed as the over spill to Boroughmuir High School.

We have taken action on an application for short term let canal boats immediately in front of Boroughmuir High. Once the school parent council starting writing letters and the numbers got north of 350 the planners did a site visit and the application was refused. This will allow the school to use their part of the canal as part of the curriculum, student learning and canoeing in the future.

Most recently we have seen the commercial ambitions of the Golf Tavern come back again with an application for a 'Golf Starter Hut' on the Links. We see it as an nothing less than an extended beer garden for the pub group and are working with the Council Officers to try and stop this. Legislation prohibits permanent structure on the Meadows or Links, which is why they the new plan focuses on a temporary starter hut to be removed during the winter months. There has been a very significant amount of local opposition to this and many people have contacted the CC to say they do not want this development on the Links.

Interestingly the proposed Botels accounted for the highest interactions with the local community during the last year, followed by the Golf Tavern and then the housing proposed on Lower Gilmore Place, which with the help of Paul Beswick resulted in a residents association being formed, which we encouraged.

Throughout the year we have seen some changes in the membership of the Community Council. Firstly, I would also like to take this opportunity to again thank Michael Lister for producing our excellent minutes, he stood down in 2018 when Saty Kaur took over.

Also, with Community Council elections coming up later in the year across Edinburgh for Community Councils I would also like to put on the record my many and varied thanks to those Community Councillors who have come to me and indicated that they will not be standing again.

We are at a time of change and I want to thank those people who have served over a very great number of years – helping to fight the fight in years past and who will be bowing out towards the end of the year. We hope that they will still attend meetings and wish them all the best for the future.


