# 7. Planning

- 19/03710/FUL: Internal alterations to existing restaurant at 4-8 Lochrin Buildings and 66 Home Street to form takeaway at 66 Home Street and erect flue to rear of No. 2 Lochrin Buildings and alterations to shopfront at 4-8 Lochrin Buildings. This is 2<sup>nd</sup> application; previous was refused in July because not enough information about amenity – music. We have objected to another takeaway
- **19/01461/FUL:** (as amended) Partial demolition of the existing building and construction of 8 flatted dwellings. Internal and external alterations to the existing shop. Committee decision. Granted 6 August 2019.
- **Meeting** with Montague Evans re S1 development of St Joseph's. Student Flats. Application by end October
- Lower Gilmore Place, Glencairn, application considered 28<sup>th</sup> August and committee voted unanimously!! to hold a hearing. The Planning report recommended approval.
